ORDINARY PARISH COUNCIL MEETING PART 1 NON –EXEMPT INFORMATION

12/57 TO RECEIVE APOLOGIES FOR ABSENCE Apologies were received and accepted from Cllr Haynes

12/58 VARIATION OF ORDER OF BUSINESS There was no variation in the order of business.

12/59 MEMBERS TO DECLARE AN INTEREST.

No declarations of interest were made

12/60 PUBLIC SPEAKING

a) Members of the Public No report was given

b) County Councillor

Cllr Mrs Patten reported that the lime trees at MCP had been attended to and that the ownership of the fence on Merlin Way had not been erected by DCC.

Cllr Mrs Patten added that the 2013/14 County Council budget is out for consultation and the views of the public are being sought together with suggestions for areas where expenditure can be cut.

Cllr Holland stated that issues raised at previous Parish Council meetings seemed to take a lengthy period of time to be resolved and that responses are slow from both SDDC and DCC. The Clerk concurred with the comment and cited recent examples in support. Cllr Mrs Patten explained why the process takes time but all Councillors said that they would take the comments back to both Councils.

c) District Councillor

The wind turbine application has been submitted to the Planning Inspectorate. Both Cllrs Lemmon and Mrs Brown have made written representations. The local MP has made attempts to get an informal hearing rather than it being determined on written submission. It was predicted that the decision is unlikely to be known until the New Year. Cllr Mrs Brown gave an explanation as to the application of the various policies used and their ranking of priority in the determination of the wind turbine application.

Cllr Mrs Brown informed that the rail freight interchange pre application will start immediately in the New Year, but it will not be a quick process. District Councillors advised that if the application obtains consent, it is large enough to trigger a review of the Local Plan. Cllr Lemmon explained why this was unwelcome and why there was a need for a Local Plan which acts as a defence to speculative applications.

RESOLVED to enable Cllrs to consider whether the Hall requires refurbishing and if so in what areas should be upgraded. The matter will be discussed at the next meeting. In the interim it was agreed that the holes in the walls will be plastered. The Clerk will arrange for the work to be undertaken.
